Opioid Grant and Obvious Expenditure Outcomes – Joe Pastuszak

Joe Pastuszak presented and answered questions about the information included in the outcomes report. These outcomes are for fiscal year 24-25. It's worth noting, two of the grants (BAART and Physician's Laboratory) are more than one-year grants. An error was found during the presentation, and an updated outcomes report will be sent to the committee via email.

Cycle 2 Opioid Settlement Grants Update

28 grant applications were received, equaling requests of over \$3 million. Region 5 Systems will award a minimum of 2 projects and up to \$650,000. The review committee is finalizing their recommendations and will release this information by September 30, 2025. The recommendations will be presented to the Behavioral Health Advisory Committee (10/29/25) and Regional Governing Board (11/10/25) for final approval. Contracts will begin January 1, 2026.
