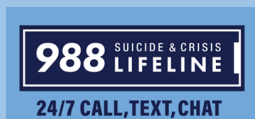

When a youth or young adult is living with a serious mental health disorder, it comes with a special set of challenges for the family. Region 5 Systems' Family & Youth Investment (FYI) is here to help. FYI uses a "wraparound" approach—utilizing the family's trusted allies and natural support systems right in their community. Families in FYI learn creative ways to meet their goals and identify the resources and supports that are unique to mental health issues.



The approach begins with the principle "voice and choice," meaning, the perspectives of the family—including the child or young adult—are given primary importance during planning and activities. This allows for goals to be individualized, family driven, culturally competent, and community based.

FYI's primary areas of focus are to:

- Avert children from becoming state wards, preventing out-of-home placements, or involvement in emergency services;
- Reduce juvenile crime or contact with adult criminal justice systems;
- Increase school performance; and
- Facilitate a seamless transition from the youth to the adult behavioral health system.



### Who do we serve?

FYI serves youth and young adults through age 25 who have a serious mental illness. Please call for a confidential screening.

**Families must meet financial and diagnostic\* eligibility requirements to receive support at no cost. For families not meeting eligibility criteria, the option of paying a monthly rate for participation is available. Please call 402-441-4343 for an appointment to determine if FYI is the right fit for your family.**
